Howard County Officials, Inc. (hereafter referred to as HCO) and Woodbine Softball Program (hereafter referred to as Woodbine), hereby enter into the following contract for the 2007 Adult Slow Pitch Softball Season:

HCO agrees to:

1. Provide Woodbine one umpire, as requested, per game, for the 2007 season
2. Provide only registered umpires in good standing.
3. Provide training for its officials and umpires prior to the beginning of the 2007 season.
4. Invoice Woodbine for services scheduled and actual. Invoices are to be sent to:

Woodbine Softball Program, G. Raymond Herche, Treasurer, 6324 Davis Rd, Mt. Airy, MD 21771-7210
HCO will invoice EYO at the end of month for each month that games are scheduled and played.

Woodbine agrees to:

1. Pay \$27.00 per umpire, per game or any partial game. However in the event that only one game is scheduled, the fee shall increase to \$32.00.
2. Pay one-half game fee per umpire in the event the Woodbine weather recording has not canceled the game by the specified time and an umpire has traveled to the site and the scheduled game is canceled due to inclement weather.
3. Upon receipt of invoice, provide HCO with prompt payment for all games scheduled for the next month.
4. Provide HCO with league schedule before the season starts. Schedule updates should be provided by the 15th of the month preceding the changes.
5. Adopt a time limit for each doubleheader such that no new inning will start after two hours and ten minutes (130 minutes).
6. Woodbine will give 24 hours notice of all cancellations; excluding weather.

This contract is in effect for the 2007 season only and may be terminated by either party with a 30-day written notice.

Contract terms are as follows: Payment is due ten (10) days after receipt of invoice. HCO will invoice monthly for services to be provided. This contract must be adhered to in order for HCO to continue to provide umpires.

HCO is acting in the capacity of an independent contractor, and is not an agent or employee of Woodbine.
